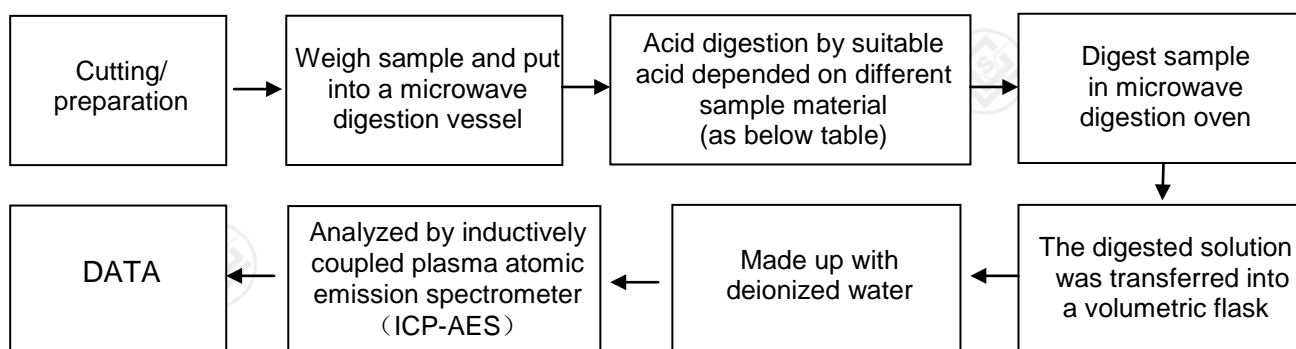

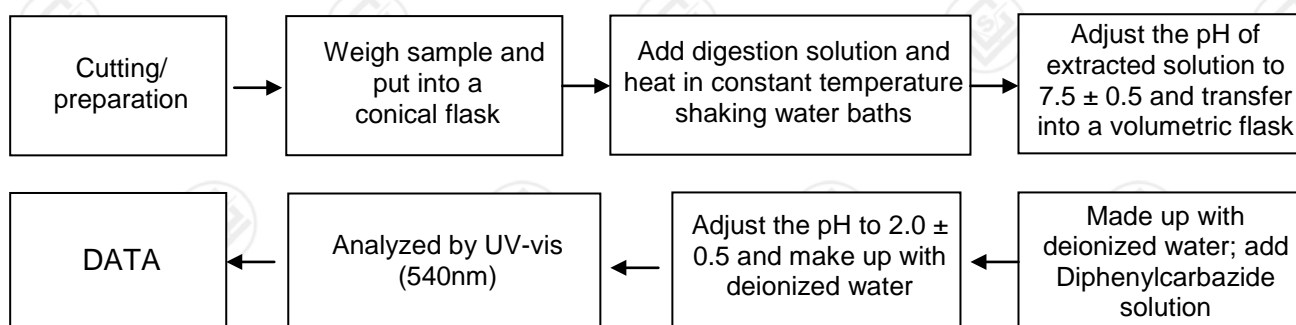

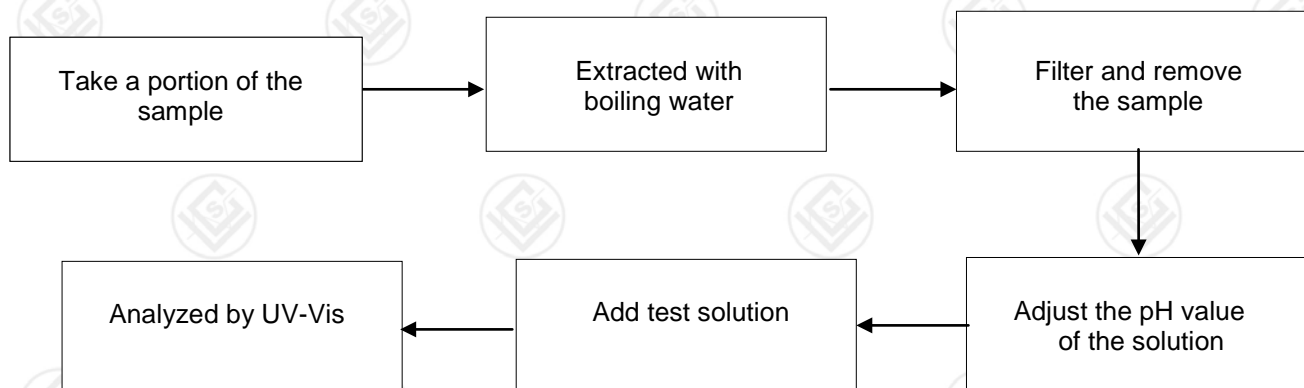
1. Test Flow chart for Cd/Pb /Hg content

Test Flowchart for Cr⁶⁺ content (For metal material)



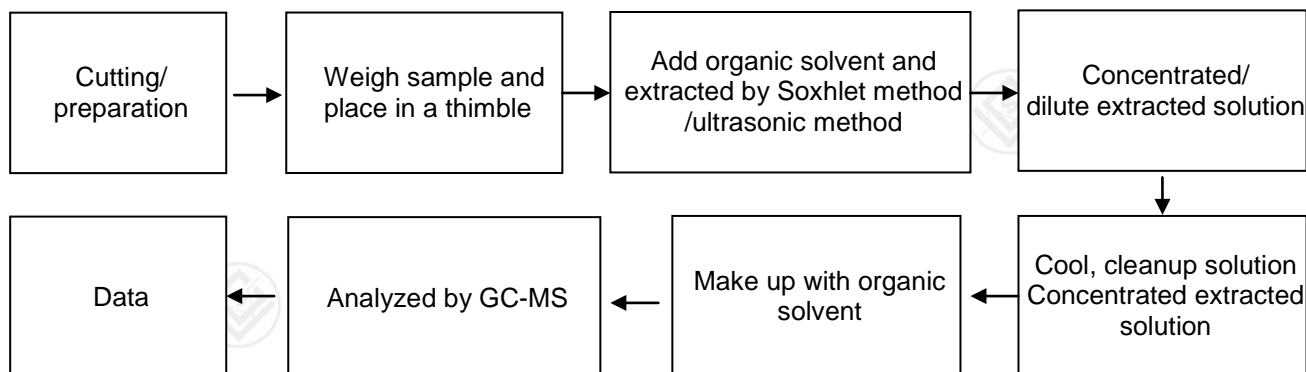

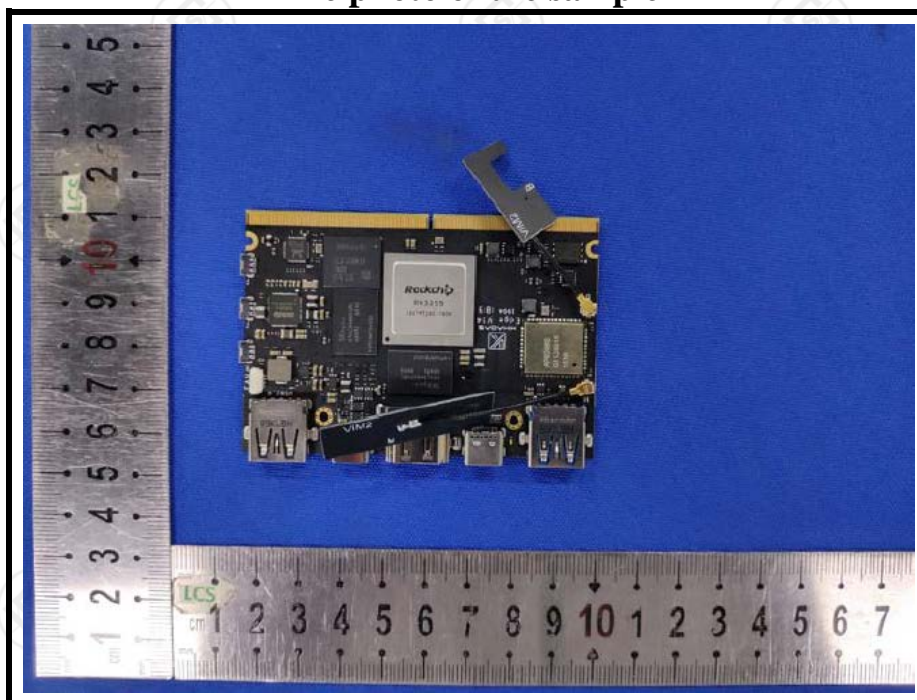

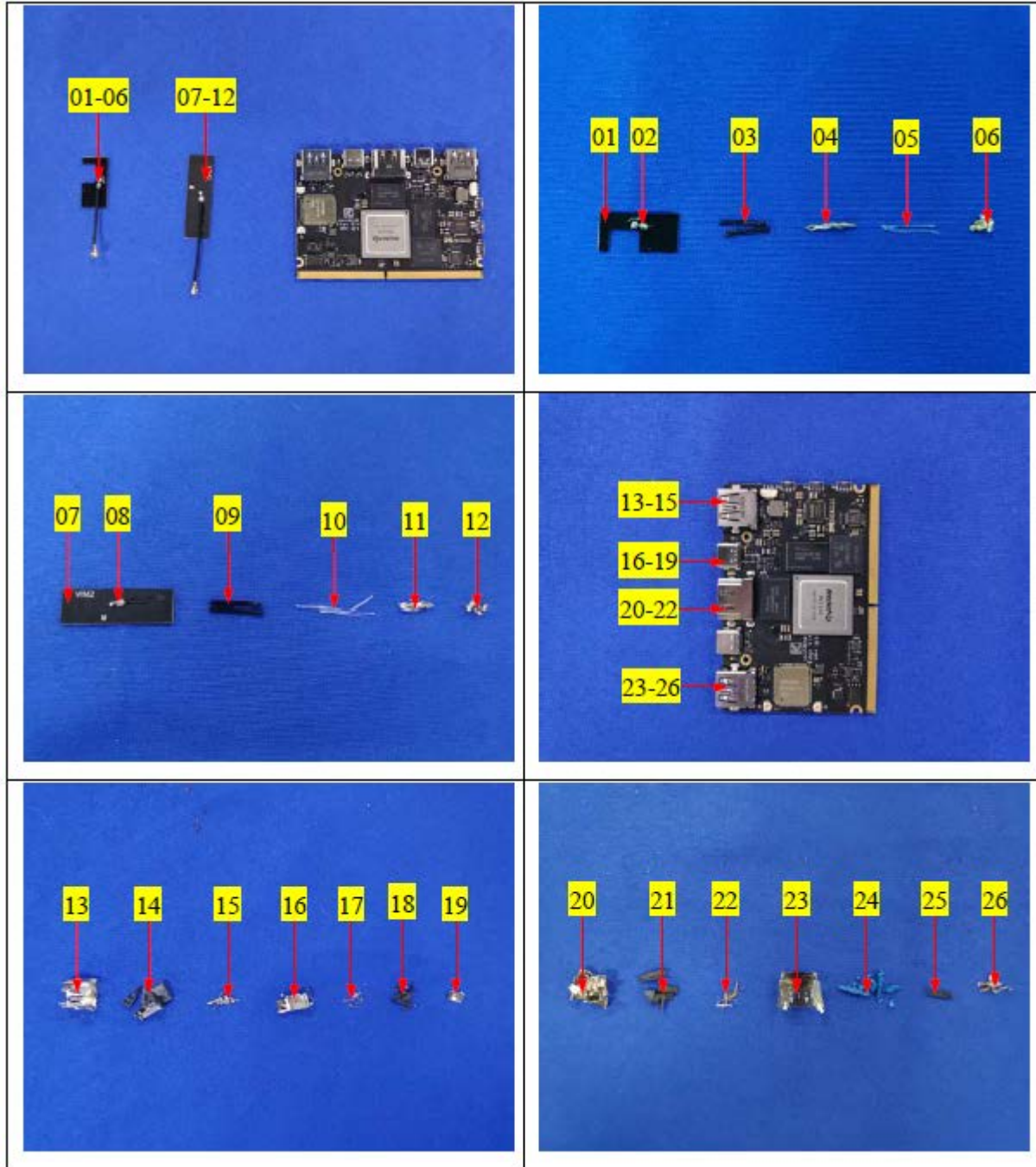

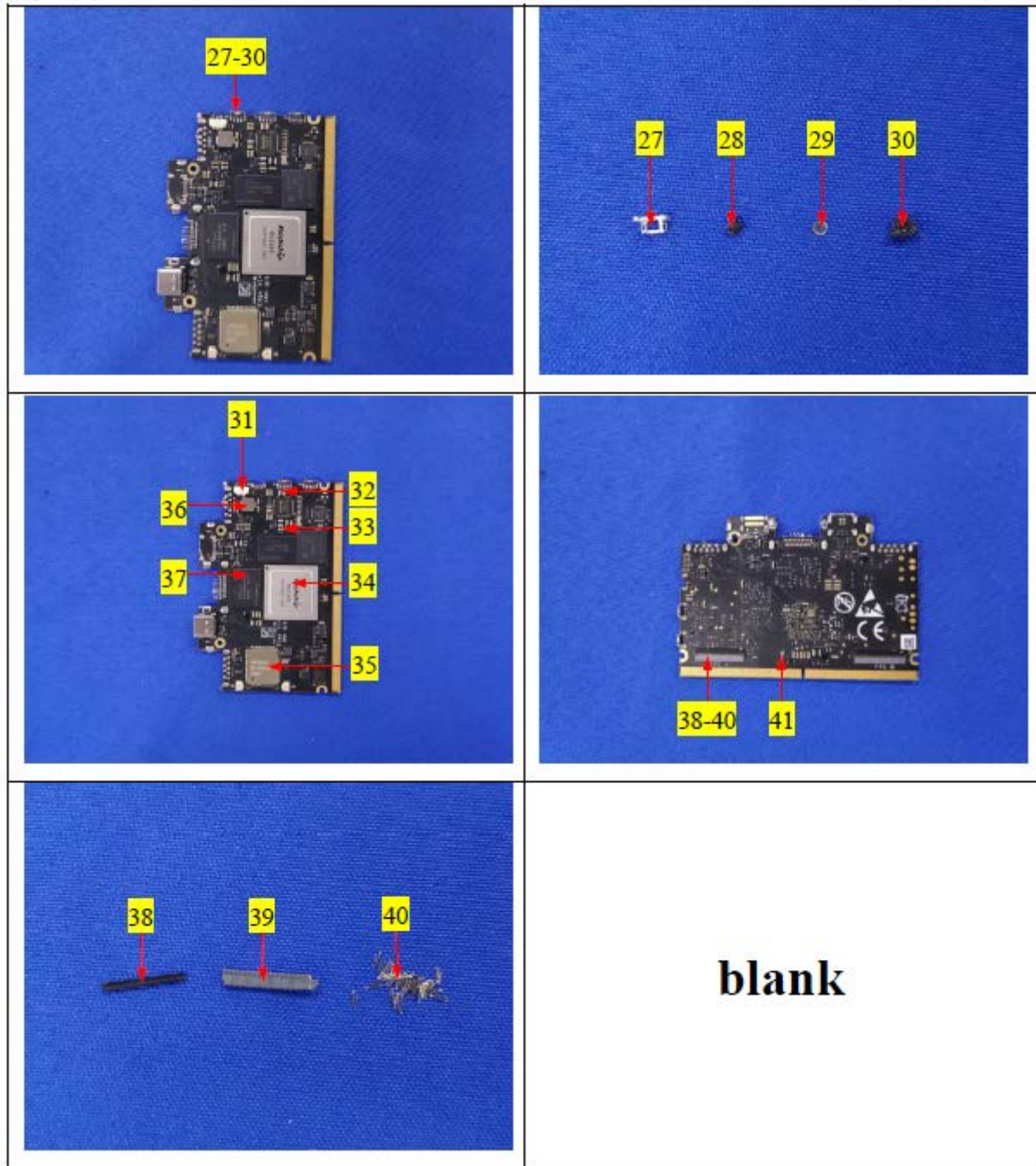
